

CATION: literate. SOCIAL STATUS AND ACTIVITIES: Gent., by 1785; third generation legislator. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: 9th Convention, Calvert County, 1776; Lower House, Calvert County, 1777 (discharged on February 19, 1777, for not having resided in Calvert County at the time of his election), 1777 (discharged from the 1777–1778 Assembly on November 4, 1777, for non-residence), 1778 (discharged from the 1778–1779 Assembly on October 28, 1778, for non-residence). MILITARY SERVICE: captain, 15th Battalion, Calvert County Militia, 1776. On July 5, 1776, the governor and Council ordered court martial proceedings against Mackall and an adjutant whom Mackall had accused of insulting him. The trial was not held because of British action in the lower Chesapeake that summer, which prevented the attendance of the defendants and witnesses. Mackall was described as not dependable in action at St. George's Island, July 29, 1776. He resigned in November 1776, but requested reinstatement on September 7, 1777. WEALTH DURING LIFETIME. PERSONAL PROPERTY: assessed value £1,135.15.0, including 23 slaves and 12 oz. plate, Anne Arundel County, 1783, and £25 for 1 slave, Calvert County, 1783; assessed value £30 for 1 slave, Calvert County, 1786. ADDITIONAL COMMENTS: Arrested for debts of £6 to £28 current money and 341 to 15,000 lbs. of tobacco on suits filed in Anne Arundel County Court between 1785 and 1791. LAND AT FIRST ELECTION: probably 919 acres in Anne Arundel and Calvert counties (800 acres in Anne Arundel County inherited from his father, 1772; ca. 119 acres in Calvert County purchased in 1771). SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: sold at least 79 acres of his Calvert County land by 1783; acquired land in Orange and Rockingham counties, Virginia, by 1789; sold all remaining land in Maryland by 1791. WEALTH AT DEATH. DIED: in 1799, probably in Rockingham County, Virginia. IDENTIFICATION PROBLEMS. The John Mackall who served in the 9th Convention may have been *John Mackall* (1738–1813).

**MACKALL, LEVIN COVINGTON** (1760–?). BORN: in 1760 in Calvert County; eldest surviving son. NATIVE: fourth generation. RESIDED: in District Two, Calvert County. FAMILY BACKGROUND. FATHER: *Benjamin Mackall, Jr.* (ca. 1723–1795), son of *Benjamin Mackall* (1675–1761). MOTHER: Rebecca, daughter of Leonard Covington (?–ca. 1742), stepdaughter of *John Hawkins, Jr.* (1713–

1757). AUNT: Barbara Mackall (1722–1757), who married *William Wilkinson* (?–1755). BROTHERS: Benjamin (died in infancy); Benjamin (1763–1822); Leonard (1768–1843); Walter (?–ca 1803); and Richard (?–1831). SISTERS: Barbara (ca. 1758–by 1795); Rebecca Covington (ca. 1770–?). MARRIED probably between 1783 and 1786. CHILDREN. Probably at least 3. PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: Anglican; member of Christ Church Parish, Calvert County. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Calvert County, 1780 (resigned during the 1st session of the 1780–1781 Assembly), 1783, 1790. LOCAL OFFICES: justice, Calvert County, 1783—at least 1787, 1789, 1791, 1794; justice, Orphans' Court, Calvert County, 1783—at least 1787, 1789–1791, 1793, 1794; Christ Church Parish Vestry, Calvert County, 1784–1787. WEALTH DURING LIFETIME. PERSONAL PROPERTY: assessed value £441.0.0, including 10 slaves, 1783; £530.10.0, including 16 slaves and 15 oz. plate, 1786. LAND AT FIRST ELECTION: probably 436 acres in Calvert County (received from father before 1783). WEALTH AT DEATH. DIED: probably between 1804 and 1810; size of estate unknown.

**MACKALL, THOMAS** (1751–1799). BORN: on August 31, 1751, in Christ Church Parish, Calvert County; fifth son. NATIVE: fourth generation. RESIDED: on “Brook Place Manor,” Third District, Calvert County. FAMILY BACKGROUND. FATHER: *James John Mackall* (1717–1772), son of *John Mackall* (1669–1739). MOTHER: Mary, daughter of Benjamin Hance (1684–1738) and wife Mary Hutchins. UNCLE: *Samuel Hance* (?–?). BROTHERS: *John Mackall* (1740–1799); *Benjamin Mackall IV* (1745–by 1810); James (1747–ca. 1837); and Richard (1749–by 1772). SISTERS: Susannah (ca. 1737–by 1782), who married *Thomas Gantt, Jr.* (?–1808); Mary (1742–?), who married *Edward Reynolds* (?–by 1820); Elizabeth (ca. 1743–?); Sarah (1752–?); Ann (ca. 1753–?); Margaret (1755–1799); Barbara (1755–?); and Priscilla (1758–1823), who married *Robert Bowie* (ca. 1750–1818). MARRIED first, Ann or Asenath (?–by 1790), daughter of *Charles Grahame* (ca. 1721–1779) and wife Asenath Hutton. Her brother was *John Grahame* (1760–1833). MARRIED second, by 1797, Ann (?–1801), possibly a Holdsworth. CHILDREN. SONS: John Grahame (1777–1828), who married Susanna Somervell; James Grahame, who married Susan Kent. DAUGHTERS: Ann (?–1814), who died without progeny. PRIVATE CAREER. EDUCATION:
