✓ The Board proceeded to the Appointment

of a fit Person to collect and receive before the first day of July 1787  
on the Behalf & Credit of this State Loans of Current Money & Tobacco  
imported since the 1<sup>st</sup> of 1785. not exceeding thirty thousand pounds in Current Money  
and three thousand Hogheads Tobacco, under the Act to vest certain Powers  
in the Governor and the Council when Daniel of St. Thomas  
Jennifer Esquire was appointed —

✓ They also proceeded to the Appointment of  
a fit and proper Person to complete & finish <sup>that</sup> Transactions and Sales  
of the late Intendant of the Revenue of the Council for Confiscated Public  
Property and to take into his Possession & care all Books and

that remains, under the Act aforesaid when

and any Act of Assembly to any Lands in Berks County for  
the purchasing the said Lands on any part thereof or Behalf  
of this State & to agree with them on the terms of the said purchase  
for a certain Annual Sum to be paid to the said Indians and  
to sell the same at Auction in Lots under the said Act  
and Daniel of St. Thomas Jennifer Esq. was appointed  
✓ adjourned till tomorrow morning 11 O'clock
