MARY MACKALL BOWIE, eldest child of Thomas Contee Bowie and his wife Mary Mackall, daughter of Governor Robert Bowie, was born December 12, 1801, at Essington, Prince George's County and was married, November 16, 1819, to Reverdy Johnson of Anne Arundel County, Maryland, at Mount Willow, near Queen Anne by the Rev. Mr. Gillis (Fed. Gaz.) A portrait of Mrs. Johnson painted by the English artist, Sully, and now in the Peabody Institute, Baltimore, shows her to have been a beautiful woman; endowed with her mother's clear practical intellect, firmness of decision and unwavering devotion to her family and intimate friends. It is said that she managed the financial affairs of her husband, while he devoted his time to public affairs.

Reverdy Johnson was of old English stock; son of the Hon. John Johnson, Judge of the Court of Appeals and Attorney-General of Maryland. His mother was Deborah, daughter of Reverdy Ghiselin, Commissioner of the Land Office at Annapolis. Reverdy Ghiselin was father of Dr. Reverdy Ghiselin who married Margaret Bowie (daughter of Governor Robert Bowie) and a grandson of Caesar Ghiselin, an early settler of Maryland. John Johnson, Jr., elder brother of Reverdy, was a distinguished chancellor of Maryland and married Mary Tyler of Upper Marlborough.

Reverdy Johnson began the practice of law in Marlborough in 1815, after graduating from St. John's College, Annapolis. Until a few years ago the little brick law office of Reverdy Johnson stood at the corner of Main and Water Streets and was one of the really interesting spots in the village. It was removed to make place for the Marlboro Implement Company's building, to the regret of the older people of the community.

In 1817 Reverdy Johnson was appointed State's Attorney for Prince George's County; two years later he removed to Baltimore; was elected to the State Senate in 1821 and was several times returned to office. He was elected to the House of Representatives and in 1849, to the United States Senate, which position he resigned to accept the Attorney-Generalship in President Taylor's cabinet. He was a Whig and a strong Union man. In 1862 he was again elected to the United States Senate and in 1866 voted for the impeachment of President Johnson. (B.B.) In 1867, he was appointed Minister to the Court of St. James and while in England, he and his wife received flattering attention. He negotiated the settlement of the "Alabama claims" and upon his return to America, was again elected to the United States Senate. Mr. Johnson was opposed to secession; he was nevertheless free from bitterness and Southern sympathizers, when in trouble, found in him a warm and influential friend.

In 1869 he and his wife celebrated their golden wedding at their home in Baltimore, where she died March 19, 1873; he, February 10, 1876.

ROBERT BOWIE of "CEDAR HILL," eldest son of Thomas Contee Bowie and his wife Mary Mackall Bowie, was born near Queen Anne, Prince George's County, April 4, 1804. He grew up at Bowieville, the beautiful home erected by his mother after his father's death. He was educated by private tutors and finished a collegiate course at St. John's College, Annapolis. He administered his mother's estate and in order to effect a division among the nine children, was compelled to sell Bowieville. On February 21, 1826 (M.L.M.) he married Margaret, daughter of George French of Washington County, Maryland, and
