


Last Will and Testament

James Fenner Lee,

I, James Fenner Lee of Baltimore County, State of Maryland, and of the United States of America, temporarily residing in Vienna, Austria-Hungary as Secretary of the Legation of the United States, declare this to be my last will and testament, and do hereby give and bequeath to my wife Mary Cornelia Lee, all of my property, real, personal and mixed, wherever situate, absolutely.

And I hereby name and appoint my said wife, Mary Cornelia Lee, sole Executrix of this my last will and testament.

Signed, and sealed at the Legation of the United States in the city of Vienna, Empire of Austria-Hungary, this second day of November, A. D. 1887, in the presence of the three subscribing witnesses.
