London Grinstead, made this sixteenth day of September in the year of our Lord one thousand eight hundred and forty  
 between London Grinstead of Green County in the State of Maryland of the one part and Mrs Wilmer of the County and  
 State a widow of the other part witnesseth, that the said London Grinstead in consideration of the sum of seven thousand dollars  
 current money of Maryland to him in hand paid by the said Mrs Wilmer before the sealing and delivering of these presents to her  
 aforesaid he the said London Grinstead hereby acknowledge and from every part and parcel thereof with hereby cognititione,  
 save and discharge said Mrs Wilmer his heirs executors and administrators he the said London Grinstead hath granted bargained  
 sold aliened and released and confirmed unto by these presents to the grant bargained sell aliened and confirmed unto the said  
 Mrs Wilmer his heirs and assigns all that part of land or parcel of lands called Allary Parry lying and being in Green County  
 bounded within the following lines more and bounds less, Beginning at a stake standing at the end of the north  
 border degrees west two miles of Oaklawn chance and running thence south seventy-three degrees and fifteen minutes west-ninety  
 perches, and south forty-six degrees east fourteen and one quarter perches and south forty-four degrees west-thirteen perches and  
 south forty-six degrees east-eighty-three perches and from thence with a straight line to the beginning containing twenty-five  
 acres of land more or less together with all and singular the buildings improvements woods ways water courses rights liberties  
 privileges here and there and appurtenances whatsoever thereto belonging or in any way appertaining and the reversion and  
 remainder and issues and profits thereof and all the estate eight-tenths and interest whatever of him the said London Grinstead  
 both at law and in equity of in to and out of the said lands and premises hereby bargained and sold or meant mentioned  
 aforesaid hereby as to be and every or any part and parcel thereof; To Have and Hold the said lands and premises  
 so aforesaid described called Allary Parry or by whatsoever other name or names the same may be called together with  
 the buildings and appurtenances and all and singular other the premises hereby bargained and sold or meant mentioned  
 aforesaid hereby as to be with this and every of their appurtenances unto the said Mrs Wilmer his heirs and assigns forever  
 and for no other use intent or purpose whatsoever and the said London Grinstead his heirs executors and administrators  
 hereby covenant grant promise and agree to and with the said Mrs Wilmer his heirs executors and administrators that  
 he the said London Grinstead and his heirs the said lands and premises hereby granted bargained and sold and every part  
 and parcel thereof with the appurtenances thereto belonging to him the said Mrs Wilmer his heirs and assigns against him  
 the said London Grinstead and his heirs and against all and every other person or persons whatsoever claiming or to claims  
 any right title or interest in and to the same or any part thereof shall and will hereafter warrant and forever defend by  
 these presents; and the said London Grinstead for himself his heirs executors and administrators with further covenant grant  
 promise and agree to and with the said Mrs Wilmer his heirs executors and administrators that he the said London Grinstead  
 and his heirs shall and will at all times hereafter whenever required thereto by the said Mrs Wilmer his  
 heirs or assigns at the proper cost and expence of the said Mrs Wilmer his heirs or assigns make and acknowledge  
 all and every such further assurance and reassurance deeds or deeds Conveyances or Conveyances devices or devices in the  
 law as he the said Mrs Wilmer his heirs or assigns or their counsel learned in the law may or shall advise devices or require for  
 the more certain or effectual assuring conveying and quieting the possession of the said Mrs Wilmer his heirs and assigns of as  
 and to the said lands and premises with the appurtenances thereto belonging whereof the said London Grinstead hath thereunto  
 subscribed his name and affixed his seal the day and year first herein before written.
