Know all men by these presents that I John Cooper of Kent County in the State of Delaware for and in consideration of the sum of Fifty Dollars to me in hand paid by Stephen Harper of Caroline County and State of Maryland at or before the sealing and delivery of these presents the receipt whereof I the said John Cooper doth hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said Stephen Harper his Executors administrators and assigns a Certain Negro Boy Slave named George Washington Harper supposed to be about seven years of age. To have and to hold the said Negro Boy slave named George Washington Harper above bargained and sold or intended so to be to the said Stephen Harper his Executors administrators and assigns forever. And I the said John Cooper for myself my heirs Executors and administrators the said Negro Boy named George Washington Harper as a slave unto the said Stephen Harper his Executors administrators and assigns against me the said John Cooper my heirs Executors and administrators shall and will hereafter warrant and forever defend by these presents, In witness whereof I have hereunto set my hand and affixed my seal this the 5th Day of July in the year of our Lord one thousand eight hundred and twenty six.
