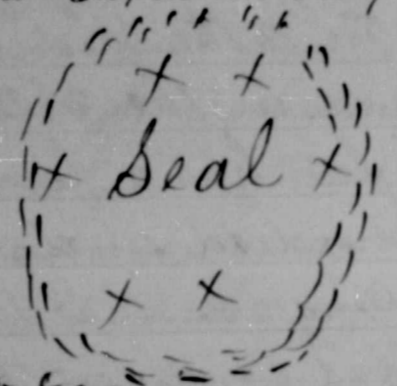
Satisfaction of Mortgage from Charles W. Jones and others To the Board of Church Extension of the Methodist Episcopal Church,

Be it remembered, that on this second day of February A.D. 1883. there was brought to be recorded among the Land Records of Kent County, a paper, marked, Satisfaction of Mortgage, which is in the words following, to wit:

Know all men by these Presents, That the "Board of Church Extension of the Methodist Episcopal Church" does hereby certify, that a certain Indenture of Mortgage, bearing date the second day of October A.D. 1869. and made and executed by Charles W. Jones, Marshall S Jones, Isaac Cotton, Samuel Gleaves, Isaac S. Jones, Josiah Cauk, Jno Sticking, Samuel J Gleaves and Isaac Cauk, Trustees of Joshua Methodist Episcopal Church of Millington Circuit, County of Kent, and State of Maryland, to secure the payment of the sum of Two hundred dollars, and interest to the said Corporation, and recorded in Book J.K.H. of Mortgages on pages 281 + 282. on the 15th day of November A.D. 1869, is fully paid, satisfied and discharged and County Clerk is hereby authorized and empowered to enter satisfaction of the same on the Record of said Mortgage.

In witness whereof, the said "Board of Church Extension of the Methodist Episcopal Church" has caused these presents to be signed by its Corresponding Secretary, and its Corporate Seal to be affixed hereunto as its act and Deed, this sixteenth day of January 1883.
