

Bill of Sale ..

Hugh H. Shaw

To

Joseph T. Mitchell

Rev.^d June 23^d 1846.

Be it Remembered, that on this Twenty-third day of June in the year Eighteen hundred and forty-six, a Bill of Sale was brought to be recorded, among the Records of Kent County as follows: Whereas, I, Hugh H. Shaw of Kent County and State of Maryland, am largely indebted to Joseph T. Mitchell of the said County for oak timber logs purchased of him and also for board of self and hands whilst engaged in getting and sawing said timber logs: And whereas, I am also indebted to him the said Joseph T. Mitchell for various sums of money due to him upon assignments from different persons to whom I am indebted and being desirous to save and defend the said Joseph T. Mitchell first for the money due and owing to him from me individually and personally, and afterwards to pay and satisfy to him the money so as aforesaid due upon said assignments, have absolutely sold to him the said Joseph T. Mitchell the oak timber and logs of oak timber and scow hereinafter mentioned - I know all men therefore by these presents, that I, Hugh H. Shaw for and in consideration of the premises and for and in consideration of the sum of five dollars current money to me in hand by the said Joseph T. Mitchell at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, I the said Hugh H. Shaw do grant, bargain and sell unto the said Joseph T. Mitchell his executors, administrators or assigns all the oak timber and all the oak timber-logs now lying and being in the woods of the said Joseph T. Mitchell on his farm on

the bay-side, and which have, cut, hewed, sawed, or dressed by me or by my servants, and also all the oak timber and oak timber logs and all other timber, and now lying on the Bay shores of the farm of him the said Joseph T. Mitchell, or on the Bay shores of the farm of Thomas R. Downe, or elsewhere, and all which timber and oak timber logs have been delivered and hauled on the said Bay shores by me, my servants or by those employed by me and one scow - To Have and To Hold, the said timber, oak timber and oak timber logs to him the said Joseph T. Mitchell, his executors, administrators or assigns - In Witness Whereof, I, Hugh H. Shaw have hereto subscribed my name and affixed my seal this twenty-third day of June Eighteen hundred and forty-six.
